**DRAWS AND DEADLINES:**

All draws will be held at the office of Kids Cancer Care Foundation of Alberta 5757 4 St SE, Calgary, AB. T2H 1K8.

The Early Bird #1 Draw for a Barley & Smoke Brews & Bites Gift Basket will be held at 2:00pm on August 27, 2024. Only tickets purchased before 11:59pm on August 26, 2024 will be eligible for this draw.

The Early Bird #2 Draw for a WestJet one (1) roundtrip flight for two (2) guests to any regularly scheduled WestJet destination will be held at 2:00pm on September 25, 2024. Only tickets purchased before 11:59pm on September 24, 2024 will be eligible for this draw.

The Final draw for 50% of total ticket sales will be held at 2:00pm on October 2, 2024. Only tickets purchased before 11:59pm on October 1, 2024 will be eligible for this draw.

Any winning ticket drawn will be returned to the draw to remain eligible for any subsequent draws.

Prize draws follow a strict set of procedures, with draw control oversight by Stride Management Corp. and under licensing approval by the licensing body, Alberta Gaming, Liquor and Cannabis (AGLC). Each prize draw will be conducted in accordance with the approved Raffle Terms and Conditions as put forth by AGLC. Draws are conducted using a Random Number Generator (RNG) system, certified, and approved by AGLC.

All the above-mentioned draws are open to any member of the public wishing to attend. Two lottery representatives or their designates will be present for all draws.

Only upon demonstrating extraordinary circumstances to Alberta Gaming, Liquor and Cannabis will the Licensee make a request for a draw date extension.

Files are continuously backed up by Stride Management Corp. In the unexpected event of a power failure, the draw will be postponed and take place immediately once power has been restored.

**ELIGIBILITY:**

Raffle guidelines prohibit the following people from purchasing tickets:

- a. Kids Cancer Care Foundation of Alberta Board members and members of their immediate family including spouse, parents, children or siblings which reside in the same household.
- b. Kids Cancer Care Foundation of Alberta salaried team.
- c. Employees of Stride Management Corp. and members of their immediate family including spouse, parents, children or siblings which reside in the same household.
- d. Anyone under the age of 18. The Licensee will advise all purchasers not to include the name of anyone under the age of 18 on the ticket due to the requirements of the Public Trustee Act.

**PRIZES:**

There is 1 Early Bird #1 Prize of a Brews & Bites Gift Basket (\$367.00 CAD Retail Value), 1 Early Bird #2 Prize of a WestJet one (1) roundtrip flight for two (2) guests to any regularly scheduled WestJet destination (\$4,240 CAD Retail Value), and one final prize of 50% of total ticket sales.

The Winners will be notified by telephone and/or email by lottery representatives; detailing what they have won and where they can claim their prize. Also, the name, city and winning ticket number will be published within 14 days on the Kids Cancer Care Foundation webpage.

Prizes must be accepted as awarded, there will be no cash substitutes unless otherwise stated.

Should the prizes not be claimed within three months of the draw date, a request will be made to Alberta Gaming, Liquor & Cannabis for a decision regarding the disbursement of the prize.

**TICKETS:**

In the event that a winning ticket stub lists more than one name, the Licensee will award the prize to the individual whose name appears first on the stub. The Licensee, Stride Management or Alberta Gaming, Liquor & Cannabis are not responsible for resolving any disputes that may arise between the different individuals.

All sets of multiple tickets must contain the same information. All tickets will be controlled by Stride Management Corp. and are only available for purchase online.

If any purchased ticket has been entered for any draw, no refund will be issued.

Tickets will not be sold outside of the province of Alberta.

Kids Cancer Care Mega 50/50 tickets available are single tickets at \$10 each, sets of 5 for \$20 each, sets of 15 for \$50, and sets of 50 for \$100. Total number of tickets available are 425,950.
